CLERKS REPORT – ACTION FROM LAST MEETING

- a) **Colton Pumping Station Update.** Cllrs Robertson reported Yorkshire Water are still awaiting planning permission. A survey of the village by Yorkshire Water regarding surface water have nothing further to report. This was carried out by MacDonald Bentley
- b) **Defibrillator, Colton** Cllr Robinson had to report that the person who he has been dealing with over the past few months has been promoted and left the department. Another lady has taken over which has delayed the procedure further.
- c) **Footpath Bolton Percy to Cricket Field Update.** Clerk has had an email from NYCC in answer to her request for a site meeting as follows: I put forward for funding to improve the path in 2019 (from junction of the village main street to the cricket ground) – Due to budget restraints we have been unsuccessful as yet, however the request is still live so we can only hope for funds in the future. I will contact you when any further progress is made. Councillors decided to investigate the path to see if it was just top soil which needed taking off.
- d) **Environment Agency.** Both Parish Clerk and Councillor Nicholls have been trying to contact Environment Agency to arrange a site visit for advice on cleaning the beck out to improve the operation of the pump. We are still awaiting a response from the Resilience Team.

PARISHIONERS ITEMS FOR DISCUSSION.

The Clerk was requested to put the following item on the agenda by a resident. **SDC Consultation for additional sites been added to the original SDC Plan which took place earlier this year.** There have been 43 sites added to the original Selby Plan over the Selby area but the only sites affecting our Parish

are two sites put forward - Bolton Percy – Land West of Oliver House, Church Lane – Mixed Use (Residential/Open space/Community Use/Greenspace Leisure/Other) and Land East of Glebe Farm, Low Farm Road – Residential. Both these sites have been put forward for rejection. There is to be a public consultation to begin 1st August until 13th September. To ask if any rejected sites should be considered and the reasons why.

The Parish Council are to put a link on the Parish Council Website for residents to give their thoughts direct to SDC. The Clerk will send out an email to all residents who have supplied their email address, You will find further instruction on Facebook and Councillor Robertson will put the link on Bolton Percy, Colton Steeton Website.
